M.A.P.E. planned for the needed balance of work and play by including a silent auction, a social night at the Peculiar Winery, a trivia night, and seemingly endless raffles.

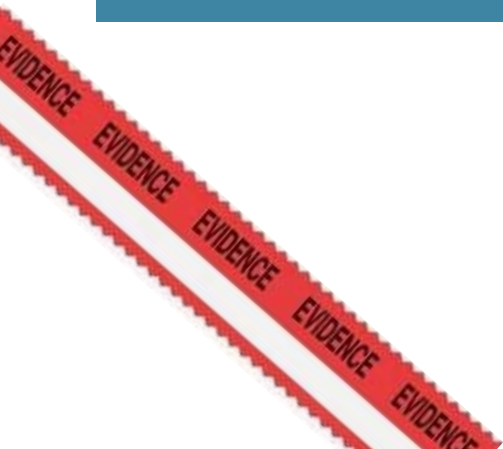
